OFFICIAL RULES AND REGULATIONS FOR EVENT ORGANIZATION

1ST PLACE FOR HOLDING EVENTS

- **Town Hall or private pavilion**
- **Party Venue (discos, banquet halls, etc.)**

2. LEGAL AUTHORIZATIONS FOR EVENTS AND SHOWS

- **Civil Liability (R/C) insurance for the event.**
- **Capacity of people**
- **Emergency exits**
- **Lighting and sound**

3rd HOMOLOGATION AND AUTHORIZATION - GLOBAL BOXING FEDERATION - GBF

1. **Official letter from the City Council or any private entity that provides the facilities for the event (sealed and signed).**
2. **Proof of payment of homologation fees (includes R/C event).**
3. **Federation licenses and valid sports medical insurance (competitors, referees and organizing staff)**
4. **Medical and ambulance service**
5. **GBF advertising posters and banners**
6. **List of participants in the competition**

4th COMPETITION REGULATIONS AND RULES - GBF

- **Know and respect the Competition Rules and Regulations**

5th PROMOTER - GLOBAL BOXING FEDERATION - GBF

- **GBF Professional Promoter License valid**
- **GBF authorization request for the event**
- **Official letter from the City Council or any private entity that provides the facilities for the event (sealed and signed).**
- **Liability Insurance (R/C) for the event**
- **The fees must be paid one month before the event (homologation and champion belt, referees and judges, etc.)**
- **Proof of payment of homologation fees**
- **The ring will be in perfect condition, as well as the approved sports equipment.**
- **Event posters with GBF logos, as well as GBF advertising banners.**

- **Failure to respect the rules, and especially those concerning competitor safety, such as a non-approved ring and protective gear used or deemed unsuitable by the supervisor, could be grounds for canceling the event.**
- **Submission of documents for federal authorizations**
- **The organizer will have the obligation to provide the video of the title fights, as well as photos of the belt presentations, etc., for official titles.**

6th COACH – ASSISTANTS AND FIGHTERS

- **At most, a coach and two assistants in the corner**
- **GBF sports passport in order**
- **GBF Professional Federation License (Coach) in force.**
- **Submit the documentation, attaching your ID card, to the GBF delegate**
- **Gym sportswear (Coach and assistants)**
- **No one other than officials, competitors, and coaches summoned for the fight taking place at that moment is allowed in the ring area.**

7. COMPLAINTS - SANCTIONS

- **All complaints must be made directly to the event organizer and in writing, or within 10 days following the date of the event.**
- **Any rude, aggressive, or annoying behavior directed at the public and officials will be immediately sanctioned by the delegate who will report to the GBF Sanctions Committee.**
- **All information regarding fights, competitors, etc. must be processed 15 days before the event in order to establish the arbitration commission and verify licenses and insurance.**
